Dear Minister Robb:

I have the honor to confirm the following understanding reached between representatives of the Government of Australia (Australia) and the Government of the United States of America (United States) (individually a "Party" and collectively the "Parties") during the negotiation of the Trans-Pacific Partnership Agreement (TPP Agreement):

Upon the request of either Party after the ninth year after entry into force of the TPP Agreement as between the United States and Australia, the Parties shall consult on global supply and demand conditions for sugar to consider the possibility of modifying market access commitments for sugar listed in the Schedule of the United States to Annex 2-D (Tariff Commitments) of the TPP Agreement.

I have the honor to propose that this letter and your letter in reply confirming that your Government shares this understanding shall constitute an agreement between our two Governments, which shall enter into force on the date of entry into force of the TPP Agreement as between the United States and Australia.
